

Directions:

Wyomissing office:

From the south and east: Take Route 422 or route 12 west, past the Berkshire Mall. Take the State Hill Road exit after the mall and turn left on to State Hill Road. At the second light, turn right on to Berkshire Boulevard, go through one traffic light and make the next right on to Berkshire Court (at the sign for Berks Visiting Nurse Association). We are the last building on the left, 40 Berkshire Court.

From West Reading, simply follow Penn Avenue west toward Wyomissing and turn right on to State Hill Road. Follow directions as above.

From the west: From the Sinking Spring area, follow Van Reed Road past the Wilson schools and turn right on to State Hill Road. After the Wal-mart shopping center, turn left on to Berkshire Boulevard, go through one traffic light and make the next right on to Berkshire Court (at the sign for Berks Visiting Nurse Association). We are the last building on the left, 40 Berkshire Court.

Alternatively, take route 422 east to the State Hill Road exit and turn left on to State Hill Road. At the second light, turn right on to Berkshire Boulevard, go through one traffic light and make the next right on to Berkshire Court (at the sign for Berks Visiting Nurse Association). We are the last building on the left, 40 Berkshire Court.

From the north: Take either route 61 or route 183 south to Route 222 (also known as the POW/MIA memorial highway or “Road to Nowhere”). Follow route 222 south, past Target, and take the 422 west exit. On 422 west, Take the State Hill Road exit after the mall and turn left on to State Hill Road. At the second light, turn right on to Berkshire Boulevard, go through one traffic light and make the next right on to Berkshire Court (at the sign for Berks Visiting Nurse Association). We are the last building on the left, 40 Berkshire Court.

Exeter office:

From the east and south: From Douglassville, Birdsboro and Pottstown areas, follow Route 422 west toward Reading. After Shelburne Plaza, make a left on to Lorane Road (there’s Commerce Bank and a Wawa at this corner). We are the red brick building on the left, behind the Commerce Bank, 25 Lorane Road.

Alternatively, from the Boyertown area, follow 562 west toward Reading. In Jacksonwald, turn left on to Shelburne Road. Follow Shelburne Road to Gibraltar Road. Turn right on to Gibraltar Road and then left on to 422 east. Turn right at the next light on to Lorane Road. We are the red brick building on the left, behind the Commerce Bank, 25 Lorane Road.

From the north and west: Follow 422 east, into Exeter. At the third traffic light in Exeter (Commerce Bank and Wawa on the corner), turn right on to Lorane Road. We are the red brick building on the left, behind the Commerce Bank, 25 Lorane Road.

Blandon/Fleetwood Office:

From the north: From the Kutztown area, take Route 222 south toward Reading. Go through Moselem Springs, eventually taking a right at the first traffic light, by the Coliseum Restaurant. Make another immediate right onto Plaza Drive. We are on the second floor of the office building, 108 Plaza Drive.

From the Hamburg/Shoemakersville area, follow 61 south to Route 73. Follow Route 73 east toward Blandon. At the traffic light, turn left on to route 222 north. At the next traffic light (just past the Coliseum Restaurant), turn left and then make an immediate right on to Plaza Drive. We are on the second floor of the office building, 108 Plaza Drive.

From the south / east: From the Oley and Blandon areas, follow Route 73 west. Turn right on to Route 222 north. At the next traffic light (just past the Coliseum Restaurant), turn left and then make an immediate right on to Plaza Drive. We are on the second floor of the office building, 108 Plaza Drive.

From the west: From the Muhlenberg area, follow either business 222 (5th street highway) or 222 north toward Allentown, going straight through the intersection with Route 73. At the next traffic light (just past the Coliseum Restaurant), turn left and then make an immediate right on to Plaza Drive. We are on the second floor of the office building, 108 Plaza Drive.
